It seems to the Department that all of the govern-
ments of the United Nations should be urged to join in
the declaration in the belief that action by all the
United Nations would give importance to the declaration,
assure better publicity and in general have a beneficial
effect on morale. Moreover, if some nations are omitted,
future events may necessitate their subscribing separately
to the declaration later. However, it is recognized
that the task of getting all the United Nations to join
in the declaration might result in unnecessary delays.
As a consequence, the Department, while favoring a joint
declaration of all the United Nations, is willing to
accept the position of the Foreign Office that the declara-
tion be limited to those of the United Nations to whom
the matter is of importance and who would have occasion
to implement it.
