FOI are INSTRS USDEL requested REPTEL for resumption quadripartite talks:

1. Purpose of forthcoming MTGS will be to conclude in shortest possible time agreement RE issues which have stood in the way of implementation Swiss Accord, and which have been SUBJ discussion over past several months. Foremost of these is compensation to GER owners liquidated properties.

2. RE compensation Allied DEFS SHLD report to Swiss RE outcome consultation with GERS and inform Swiss FEDGOV has not (RPT not) agreed take initiative on compensation plan. At same time Allied DEFS SHLD state intention issue ANC law RE compensation after agreement referred to PARA 1 has been signed and approved by ~~SWISS~~ Draft ANC law RE compensation SHLD be submitted to Swiss for INFO and with statement that Allies regard it as fulfillment APR 20 understanding and valid basis for Swiss implementation Accord.
