## An Unassuming Hero's Legacy

"The camp is filthy beyond description. Sanitation is virtually unknown. Words fail me when I try to think of an adequate description... The people of the camp themselves appear demoralized beyond hope of rehabilitation. They appear to be beaten both spiritually and physically, with no hopes or incentives for the future..."

These words were written in September, 1945 by Col. Irving Heymont to his wife Joan, describing the conditions at the Landsberg Displaced Persons Camp, the largest DP camp in Europe. At the young age of 27, he was tasked with serving as its commander, providing the survivors with the opportunity to regain their dignity and self-determination.

Many years later, Heymont concluded that "the few months I spent at Landsberg had a greater impact on my outlook on life than any other experience in my career." He learned that "despite the deepest inhumanity suffered, the spirit of a people to survive and recover cannot be crushed." The town of Landsberg and its history continued to play a significant role in his life, and in 1989 they honored him by naming a street *Irving-Heymont Strasse*.

Col. Heymont was awarded the Silver Star for gallantry in action in 1945, one of his numerous decorations. He and his late wife Joan had two children, eight grandchildren, and six great-grandchildren.

Because of his deep connection with the Holocaust and its aftermath, he

In this issue of *Generations*, we share information about how, through a charitable gift annuity, you can make a meaningful gift while preserving, or even enhancing, your financial security.

By giving in this way you, in effect, create an "endowment" today. A predetermined rate of payment is made to you for the rest of your lifetime. The remainder will be used to support our permanent endowment fund, which provides annual, ongoing support for all the Museum's endeavors.

## Gift Annuities: A Creative Way to Give and Enjoy Stable Income

Many United States Holocaust Memorial Museum supporters have discovered the benefits of charitable gift annuities. Senior Planned Giving Officer Naomi Katz has worked with many individuals who have given in this way.

**Q.** How does a gift annuity work?

**A.** A supporter simply transfers cash or other appropriate assets to the Museum, and in return receives generous fixed payments for the rest of his or her life. Payments are determined based on age, payment rate, and other factors.

**Q.** Will my payments change from year to year?

**A.** No, the amount of your payment is set when your annuity begins.

**Q.** Are there tax benefits?

**A.** Yes. There can be a combination of income, capital gain, and estate tax savings.

**Q.** Can more than one person receive payments?

**A.** Yes, two people can receive payments from a particular gift annuity. You can designate others to receive payments either with you, instead of you, or after your lifetime.

**Q.** Can I use low-yielding securities to fund a gift annuity?

**A.** Yes. This may allow you to increase your spendable income, since a gift annuity may pay more and be taxed more favorably than other income. There can be additional tax benefits if the securities have increased in value because you avoid the tax on a portion of the capital gain in the property.

**Q.** How secure are my payments?

**A.** The Museum follows the annuity rates promulgated by the American Council on Gift Annuities. The rates anticipate that in addition to earnings on any annuity funds, approximately one-half of the amount contributed will be returned over time to the annuity payment recipients. Payments are made from the funds that are contributed and administered by State Street Global Advisors, the Museum's charitable gift annuity custodian. The assets of the Museum stand behind gift annuity payment obligations.



always felt passionate about the United States Holocaust Memorial Museum's mission, believing that we all have a responsibility to teach this history. Heymont chose to support the Museum's efforts by contributing photographs and oral testimony to the Museum's collection.

He also established three charitable gift annuities that provided him with steady income and other tax benefits during his lifetime and, following his death on March 17, 2009 at age 90, will now support the Museum's endowment. In this way, Irving Heymont's extraordinary legacy lives on.


